### ***Pre-Admission TESTING for Prospective LPN-A.D.N. Bridge Students for the Spring Semester 2012***

***Location: SWGTC Main Campus, Thomasville, GA***

#### **ATTENTION LPN – A.D.N. Bridge Applicants!**

You may register for the LPN – A.D.N. Pre-Nursing Assessment Exam by calling Student Affairs 229-225-5060 or by coming into the Student Affairs office and put your name, SWGTC Student ID or SS# and telephone number on the sign-up sheet. Make sure you are ready to commit to the testing session you select...once the testing fee has been charged there will be no refunds, no withdrawals! Testing fees will be entered on the registration deadline dates listed below.

#### **NOTES Regarding HESI Sign-Up:**

- You must have submitted a SWGTC admission application & application fee; all official transcripts (post-secondary) & have completed all or a majority of your pre-requisite courses before testing.
- There will be NO refund and NO withdrawal from a testing session.
- You MUST bring valid picture ID to testing session. NO ONE WILL BE ADMITTED WITHOUT PICTURE ID.
- Arrive ½ hour early. NO ONE WILL BE ADMITTED AFTER POSTED TIME TO BEGIN TESTING SESSION.

***HESI Exam Costs: \$50.00 (includes 2 exams: Fundamentals & Pyschiatric/Mental Health).***

***Required Score: 650 Fundamental & 450 Psychiatric/Mental Health***

***Students are allowed two (2) attempts to pass this exam within 1 calendar year.***

***If you have to re-test – you will only need to take the session(s) of the exam in which you did not make the required score. Retest fee: \$25.00 per section***
